

RESOLUTION NO. 2024 - ____

RESOLUTION ESTABLISHING A NO PARKING ZONE FOR VEHICLES OVER SIX FEET TALL NORTH OF THE SANTA LUCIA AVENUE AND EL CAMINO REAL INTERSECTION; MODIFYING THE TIMES FOR THE NO STOPPING ZONE ON THE NORTH SIDE OF ANGUS AVENUE WEST FROM MASSON AVENUE TO HENSLEY AVENUE; AND FINDING SUCH ACTION EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT

WHEREAS, pursuant to Title VII, Section 7.12.030 of the San Bruno Municipal Code grants the City Traffic Engineer the duty and responsibility for placing and maintaining traffic control devices he or she deems necessary to guide or warn traffic based on engineering principles and investigations;

WHEREAS, sight distance is limited by large trucks parked near the northwest corner of the Santa Lucia Ave and El Camino Real intersection;

WHEREAS, Exhibit A illustrates the proposed and existing parking restrictions on El Camino Real; and

WHEREAS, parking on Angus Avenue West from Masson Ave to El Camino Real can cause congestion if the volumes are heavy;

WHEREAS, volume of traffic on Angus Avenue West from Masson Ave to El Camino Real appears to contribute to congestion between 12:00 p.m. until 8:00 p.m.;

WHEREAS, Exhibit B illustrates the proposed parking restrictions on Angus Avenue West; and

WHEREAS, this action is exempt from the California Environmental Quality Act, pursuant to CEQA Guidelines Section 15301(c), existing facilities which exempts minor alterations of existing streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities. This project will not cause an expansion of an existing use of the streets.

NOW, THEREFORE, BE IT RESOLVED that the City Council hereby: (i) establishes a 40 foot "No Parking Zone" for vehicles over six (6) feet on El Camino Real from 40 feet to 80 feet north of the Santa Lucia Ave and El Camino Real intersection along the curb, and (ii) modifies the existing no stopping zone on the north side of Angus Avenue West from Masson Avenue to Hensley Avenue by changing the prohibited hours of 8:00 a.m. to 6:00 p.m. to 8:00 a.m. to 8:00 p.m.

AND, BE IT FURTHER RESOLVED that the City Council hereby determines this action is exempt from the California Environmental Quality Act, pursuant to CEQA Guidelines Section 15301(c).
