

RESOLUTION NO. 2022- ____

ADOPT RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT AMENDMENT WITH ZERO TURN POWER WASHING TO PROVIDE MONTHLY DOWNTOWN SIDEWALK PRESSURE WASHING SERVICES IN AN AMOUNT NOT TO EXCEED \$28,100 FOR THE REMAINDER OF FY 2021-22 AND TO INCREASE FY2021-22 STORMWATER FUND BUDGET BY \$28,100

WHEREAS, following approval of the contract at the April 14, 2020 City Council Meeting, the City utilizes Zero Turn Power Washing of San Carlos, California, to pressure wash and clean the City's downtown sidewalks along San Mateo Avenue between El Camino Real and Huntington Avenue and adjacent side streets; and

WHEREAS, project work includes, but not limited to, removing gum, heavily soiled or miscellaneous stains from the sidewalks using only hot, pressurized water and without chemicals or cleaning agents, and reclaiming the cleaning water instead of passing the used water directly into the stormwater system; and

WHEREAS, following community requests for more frequent sidewalk cleanings, staff is proposing to increase the cleaning schedule from six to twelve annual cleanings, or from every other month to a monthly schedule; and

WHEREAS, an amendment to the existing contract is required to increase the scope of work, with the term of the contract and all other original requirements remaining the same; and

WHEREAS, the cost for three additional cleanings through the end of June 2022 is \$28,100, increasing the original annual contract amount of \$56,200 to an updated total amount of \$84,300 for FY 2021-22; and

WHEREAS, an increase to the FY2021-22 Stormwater Fund budget by \$28,1800 is requested to fund the enhanced cleaning schedule through June 2022; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of San Bruno to adopt resolution authorizing the City Manager to execute a contract amendment with Zero Turn Power Washing to provide monthly downtown sidewalk pressure washing services in an amount not to exceed \$28,100 for the remainder of FY 2021-22 and to increase the FY 2021-22 Stormwater Fund budget by \$28,100.
