5. ANNOUNCEMENTS/PRESENTATIONS

7. CONDUCT OF BUSINESS

- a. Waive First Reading and Introduce an Ordinance Amending Chapter 10.16 (Water Conservation) of the San Bruno Municipal Code.

Public Works Director Lee presented the item to the City Council and answered questions.

West Yost Consultant Rhodora Biagtan presented the item and answered questions.

Water Quality Technician Salazar commended the community's conservation efforts and stressed the City's commitment to a reliable water supply of good quality.

M/S Hamilton/Medina, the motion carried by a unanimous vote.

- b. Study Session for the Release of the Draft 2023 - 2031 Housing Element.

Community & Economic Development Director Wu presented the item to the City Council and answered questions.

Senior Planner Smith also presented the item to the City Council and answered questions.

Member of the Public Paul Wapensky spoke about the additional people this plan will bring to San Bruno during a time of water conservation.

- c. Appointment of Two City Councilmembers to the Fireworks Application Review Subcommittee.

The council discussed and agreed unanimously that staff has been following the requirements outlined in Resolution 2008-67 when accepting and reviewing applications submitted by the community's non-profit groups operate fireworks stands. It is unnecessary to appoint a subcommittee for further review of the applications, however in the future, any councilmember may request a discussion and the item will be agendized.

8. COMMENTS FROM COUNCIL MEMBERS

Councilmember Medina encouraged people to volunteer at the Second Harvest grocery distribution held at Belle Air Elementary at 350 3rd Avenue from 1:45 – 4:00 p.m. where about 200 families in need benefit. He also congratulated the Capuchino High School softball and baseball teams for a great year.

Councilmember Hamilton announced that the on Saturday, May 28th the American Legion monthly pancake breakfast will be held at 8:00 a.m. at their hall located at 757 San Mateo Avenue. It just returned in April after being postponed since Covid. He also spoke about the senseless and reprehensible school shooting in Uvalde Texas that day and requested that the meeting be closed in memory of the victims.

Vice Mayor Mason asked the Parks & Recreation Department to coordinate with the PTA's regarding available opportunities for them to operate the snack booth at Lara Field as a fundraiser during baseball season. She also thanked Recology San Bruno for the compost give away event. She commended the San Bruno Education Foundation for their commitment and the hard work they do, they had their annual fundraiser on May 14th and encouraged residents to mark their calendars for next year so they can participate and show their support. She also thanked City Staff for working so thoughtfully to bring diversity to our city events it is very appreciated by our residents. She also echoed Councilmember Hamilton's comments about the school shooting in Uvalde Texas that day.

Mayor Medina thanked everyone who attended and all the volunteers who made Community Drop Off Day possible. He also congratulated all the graduates and concurred that the meeting will be closed in memory of those that lost their lives in the school shooting and commented on how tragic it is that people go to work and to school as part of a normal daily routine and then don't come home that day.

9. ADJOURNMENT –

This meeting adjourned at 8:43 p.m. The City Council reconvened its Closed Session which had been recessed since 5:30 p.m. The Closed Session adjourned at 9:19 p.m.

City Attorney Zafferano reported that the City Council voted unanimously to approve joining litigation already filed by San Mateo County and many other cities in the county against Monsanto over PCB Contamination and the clean up costs.

The next Regular City Council Meeting will be held on June 14, 2022 at 7:00 p.m.
