**RESOLUTION APPROVING VARIOUS PARKING RESTRICTION CHANGES ON
LINDEN AVENUE SOUTH OF ANGUS AVENUE WEST AND DETERMINING
THE PROJECT IS EXEMPT UNDER THE CALIFORNIA ENVIRONMENTAL QUALITY
ACT**

WHEREAS, pursuant to Title VII, Section 7.08.040, the Traffic Safety and Parking Committee (TSPC) is tasked with reviewing and recommending to the City Council areas in which parking is prohibited or restricted on streets within the public right of way; and

WHEREAS, pursuant to Title VII, Section 7.08.050, of the San Bruno Municipal Code, any action of the City Council following a recommendation from the Department of Public Works and the Traffic Safety and Parking Committee (TSPC) shall be taken by resolution; and

WHEREAS, pursuant to Title VII, Section 7.12.030 of the San Bruno Municipal Code grants the City Traffic Engineer the duty and responsibility for placing and maintaining traffic control devices he or she deems necessary to guide or warn traffic based on engineering principles and investigations; and

WHEREAS, the Decima Allen Elementary School, located on the corner of Angus Avenue West and Linden Avenue has modified their driveway access on the Linden Avenue sidewalk as part of their Decima Allen Elementary School Replacement Project making certain red curb obsolete; and

WHEREAS, the San Bruno Fire Department and the City of San Bruno Employee Parking Lot have driveways on Linden Avenue that fire apparatus utilize; and

WHEREAS, Resolution 1981-71, adopted August 24, 1981, created No Parking Zones on both sides of Linden Avenue south of Angus Avenue; and

WHEREAS, Resolution 2004-10, adopted February 10, 2004, established a 1-hour parking zone on Linden Avenue spanning approximately 500 feet south from Angus Avenue West the No Parking Zones on Linden Avenue, making ambiguous the status of certain previously installed red curbs; and

WHEREAS, the Traffic Safety and Parking Committee reviewed and concurred with the proposed curb striping at the location mentioned above; and

WHEREAS, Attachment 2 of the City Council Staff Report illustrates the proposed changes to the parking restrictions on Linden Avenue; and

WHEREAS, modifying the No Parking Zones on Linden Avenue south of Angus Avenue west would improve traffic circulation and fire access and clarify the status of previously established red curbs; and

WHEREAS, this action is exempt from the California Environmental Quality Act, pursuant to CEQA Guidelines Section 15301(c), existing facilities which exempts minor alterations of existing streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities. This project will not cause an expansion of an existing use of the streets; and

NOW, THEREFORE, BE IT RESOLVED that the City Council hereby adopts a resolution approving the following:

1. Re-establish an approximate 125 foot No Parking Zone along both sides of Linden Avenue from the library walkway to Angus Avenue, excluding the existing yellow loading zone.
2. Re-establish an approximate 48 foot No Parking Zone along both sides of Linden Avenue adjacent to the City Parking Stalls adjacent to the southernly end of City Hall.
3. Re-establish a No Parking Zone along the easterly side of Linden Avenue between Fire Station 51 and the City Employee Parking Lot.
4. Re-establish an approximate 97 foot No Parking Zone along the westerly side of Linden Ave across from Fire Station 51.
5. Establish a 10 foot No Parking Zone along the easterly side of Linden Avenue from north of the Fire Station Driveway.
6. Establish an 18 inch No Parking Zone along the easterly side of Linden Avenue from south of the City of San Bruno Employee Parking Lot Exit adjacent to the Fire Station.

AND, BE IT FURTHER RESOLVED that the City Council hereby determines this action is exempt from the California Environmental Quality Act, pursuant to CEQA Guidelines Section 15301(c).
