

RESOLUTION NO. 2023- ____

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN BRUNO APPROVING THE DESIGN OF THE 2022-23 SLURRY SEAL PROJECT; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH AMERICAN ASPHALT REPAIR & RESURFACING COMPANY, INC. FOR THE 2022-23 SLURRY SEAL PROJECT IN AN AMOUNT NOT TO EXCEED \$909,305.41; APPROVING A MATERIAL TESTING AGREEMENT WITH SMITH-EMERY OF SAN FRANCISCO, INC. IN AN AMOUNT NOT TO EXCEED \$35,000.00; APPROVING A CONSTRUCTION INSPECTION SERVICES AGREEMENT WITH CONSOR PMCM, INC. IN AN AMOUNT TO NOT EXCEED \$75,000.00; APPROVING A CONSTRUCTION CONTINGENCY OF \$136,395.81; AND DETERMINING THE PROJECT IS EXEMPT UNDER THE CALIFORNIA ENVIRONMENTAL QUALITY ACT

WHEREAS, the City's Capital Improvement Program (CIP) includes the Pavement Management Program (PMP) to repair and apply preventative maintenance treatment to local, collector, and arterial streets; and

WHEREAS, treatments vary from applying preventative maintenance on streets in good condition to reconstruction of failed streets; and

WHEREAS, preventative maintenance is considered the most cost-effective treatment when applied appropriately; and

WHEREAS, the 2022-23 Slurry Seal Project is a preventative maintenance project that will apply a slurry seal treatment to various streets throughout the City; and

WHEREAS, on September 27, 2022, City Council adopted a resolution authorizing the City Manager to execute an agreement for consultant services with CSG Consultants, Inc. for the design of the 2022-23 Slurry Seal Project; and

WHEREAS, two additional pavement projects are currently on an actively accelerated schedule for design completion this calendar year, being: (i) the 2021-22 Street Reconstruction Project estimated for design completion in Summer/Fall 2023 and construction to begin in Fall/Winter 2023, and (ii) the 2022-23 Street Rehabilitation Project estimated for design completion in Summer 2023 and construction to begin in Fall/Winter 2023; and

WHEREAS, the start of construction will depend on weather conditions and staff anticipates returning to City Council to request authorization to award construction contracts for the two pavement projects in Summer 2023; and

WHEREAS, in early April 2023, CSG Consultants, Inc. completed the project final design for the 2022-23 Slurry Seal Project; and

WHEREAS, in April 2023, the City issued a notice inviting bids for the construction of the 2022-23 Slurry Seal Project; and

WHEREAS, notice to bidders was sent to contractors listed in the City's contractor directory, posted on the City's website, provided to construction distribution centers, and advertised twice in the San Mateo County Times newspaper; and

WHEREAS, on April 17, 2023, staff conducted the bid opening for the project and received one bid; and

WHEREAS, the base bid was from American Asphalt Repair & Resurfacing Company, Inc. in the amount of \$737,788.96 and total of bid additives 1 and 2 of \$171,516.45; and

WHEREAS, the total bid (including base and all bid additives) from American Asphalt Repair & Resurfacing Company, Inc. is \$909,305.41, approximately \$220,000 below the engineer's estimate; and

WHEREAS, American Asphalt Repair & Resurfacing Company, Inc. has satisfactorily completed slurry seal projects for public agencies in the Bay Area, meets the contractor qualifications, and has a valid contractor's license required to perform the scope of work of this project; and

WHEREAS, the 2022-23 Slurry Seal Project is a project within the approved FY 2022-23 Capital Improvement Program and adequate project budget is available to fund the construction contract.

NOW, THEREFORE, BE IT RESOLVED that the San Bruno City Council hereby:

- Approves the 2022-23 Slurry Seal Project design;
- Authorizes the City Manager to execute a construction contract with American Asphalt Repair & Resurfacing Company, Inc. for the 2022-23 Slurry Seal Project in an amount not to exceed \$909,305.41;
- Approves a Material Testing Agreement with Smith-Emery of San Francisco, Inc. in an amount not to exceed \$35,000.00;
- Approves a Construction Inspection Services Agreement with Consor PMCM, Inc. in an amount not to exceed \$75,000.00;
- Approves a construction contingency of \$136,395.81; and
- Determines that the Project is exempt under Section 15301 (c) of the California Environmental Quality Act Guidelines as repair and maintenance of existing streets.
