1. **CALL TO ORDER**

The meeting was called to order at 6:02 p.m.

2. ROLL CALL

Councilmembers Alvarez, Medina, Salazar, Vice Mayor Hamilton and Mayor R. Medina were all present.

3. PUBLIC COMMENTS FOR ITEMS NOT ON THE AGENDA.

4. **CONDUCT OF BUSINESS**

- a. Consider Adoption of Three Resolutions as Follows:
 - Authorizing the Creation of a Parking Enterprise Fund and the Transfer of \$2 Million From the General Fund Capital Reserve into the Parking Enterprise Fund;
 - Authorizing the City Manager to Execute a Contract with LAZ Services in an Amount Not to Exceed \$2.75 Million for Services Related to Parking Enforcement and Metered Parking Management;
 - Authorizing the City Manager to Execute a Contract with T2 Systems in an Amount Not to Exceed \$1.3 Million for Services Related to the Purchase, Installation and Operation of Metered Parking Kiosks.

Councilmembers M. Medina and Salazar recused themselves from this item, the location of their homes is close enough to the project to cause a potential conflict of interest.

City Manager Grogan gave a brief overview of the item and introduced Police Chief Ryan Johansen.

Police Chief Johansen presented the item to the City Council and answered questions.

Member of the public Marsha Glasner who urged the City Council not to charge for parking in the downtown believing that it may drive shoppers to areas that offer free parking.
