**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN BRUNO RENEWING  
THE MILITARY EQUIPMENT USE ORDINANCE NO. 2022-1910**

**WHEREAS**, in April 2022, the San Bruno City Council Adopted the Military Equipment Use Ordinance No. 2022-1910, pursuant to California Assembly Bill 481 (AB 481); and

**WHEREAS**, AB 481 requires that City Council receive an Annual Military Equipment Use Report (the "Report", review the report for compliance with Ordinance No. 2022-1910, and vote on whether to renew the ordinance each year; and

**WHEREAS**, the San Bruno Police Department's military equipment policy has been posted on the Police Department's website continuously since April 2022; and

**WHEREAS**, the San Bruno City Council has received and reviewed the Report, and Ordinance No. 2022-1910; and

**WHEREAS**, during the City Council meeting on May 23, 2023, the San Bruno Police Department provided an opportunity for public to provide feedback and ask questions about the Report and Ordinance No. 2022-1910; and

**WHEREAS**, the Chief of Police has indicated compliance with the Military Equipment Use Ordinance No. 2022-1910 throughout 2022; and

**WHEREAS**, the City Council has reviewed the Report and Ordinance No. 2022-1910; and

**NOW, THEREFORE, BE IT RESOLVED** that the City Council hereby determines, based on the Report and in accordance with California Government Code Section 7071 (d), that:

(A) The military equipment is necessary because there is no reasonable alternative that can achieve the same objective of officer and civilian safety,

(B) The military equipment use policy safeguards the public's welfare, safety, civil rights, and civil liberties,

(C) If purchasing the equipment, the equipment is reasonably cost effective compared to available alternatives that can achieve the same objective of officer and civilian safety,

(D) Prior military equipment use complied with the military equipment use policy that was in effect at the time, or if prior uses did not comply with the accompanying military

equipment use policy, corrective action has been taken to remedy nonconforming uses and ensure future compliance: and

**AND BE IT FURTHER RESOLVED** that the City Council hereby renews the Military Equipment Use Ordinance No. 2022-1910.
